Background: Oakridge Archers are a small Field Archery Club based at Shrigley Hall, Macclesfield, Cheshire. The Club is a member of the NFAS (National Field Archery Society) and as such is governed by their rules and regulations and all members are covered by their insurance. Only NFAS archers are permitted in the wood or persons receiving coaching or on a Try Day accompanied by instructors and experienced archers. All Oakridge archers are required to wear bright red tops.

Managing risk: Instructors will hold the appropriate qualification for teaching archery.
